



ARTICLES

1. Teams using ineligible players, not 25 years or older (MSBL 25+), or not 18 years or older (MABL) or not 35 years old or older (MSBL 35+), or not 45 years or older (MSBL 45+), with the exceptions of special waivers, shall forfeit all games played in which ineligible player was used. **NO APPEAL WILL BE ALLOWED ON THIS INFRACTION.**

2. If any local member's conduct is not in the best interest of the MSBL/MABL of North County San Diego, That member or team may be suspended or expelled from the league by the League president. Notification of all Board members is required prior to official notification of member. Members may also be excluded from the post season play, including participation in the MSBL/MABL World Series.

3. Any player, coach, manager, bat boy, scorekeeper, or team affiliate who is ejected from a game shall receive a one (1) game automatic suspension or a twenty-five (\$25.00) fine. **NO APPEAL WILL BE ALLOWED.**

4. Any player, coach, manager, team affiliated or umpire that takes part in any aggressive physical contact such as pushing or shoving, shall receive no less than a three (3) game suspension and may be subject to further suspension or expulsion from the league depending the involvement and intensity of the contact. **SUBJECT TO REVIEW BY BOARD OF DIRECTORS AND LEAGUE PRESIDENT.**

A. Anyone violating Article 4 shall automatically receive a one (1) year probation. (This is not subject to appeal). If Article 4 is violated a second time, the individual in question shall be expelled from the league.

B. Anyone under investigation for harmful physical contact will not be allowed to play until matter is resolved.

5. Any player, coach, or manager found to have engaged in unethical recruiting practices or tampering with a player under contract to another team, without express written consent from the player's manager, shall be subjected to being fined and suspended as manager of his team.

6. Any manager who fails to comply with league requests and/or responsibilities shall be subject to fines and removal as team manager.

7. Any player, coach, manager or team affiliate who engages in abusive behavior toward other players, umpires, spectators or league officers shall be suspended no less than two (2) games. If the player continues in abusive behavior after the suspension, that player shall be subjected to expulsion from the League.

8. Any player using illegal equipment shall be subject to no more than a three (3) game suspension.

9. Any player who fails to conform to the leagues Preamble, after being warned by the League President, shall be subject to removal from the league.

10. Any manager who fails to conform to the league Preamble, after being warned by the League president, shall be subject to removal as team manager.

11. Any team that fails to conform to the league Preamble, after being warned by the League president, shall be subject to removal from the league.

12. Any player, coach or manager who causes his team to forfeit a game through his actions, is subject to paying the appropriate team fine OF \$75.00 (SEVENTY-FIVE) before he is allowed to return to the team.

13 In the event any player, coach, manager or team violates the spirit of competition, (i.e.

- tries to gain an unfair advantage over their opponents) the League president reserves the right to take whatever steps are deemed necessary to bring equality back to a team or the league.

14. This is an amateur league, therefore no member of the MSBL/MABL of North County San Diego shall receive compensation, monetary or otherwise, for participation in any sanction MSBL/MABL game.
